GIFT DEED

This GIFT DEED is made on this 14th day of oct 2015
BETWEEN Prehlad Singh s/o. G. G. Phool Singh resident of
village Ribba Tehsil Moorang District Kinnaur, Himachal Pradesh
(hereinafter called DONOR) of the one part AND the State of H.P. through Executive
Engineer, B&R Division, HP, PWD Kalpa, Tehsil Moorang District
Kinnaur Himachal Pradesh (hereinafter called the DONEE) of the other part.

WHEREBY it is declared as follows :-

1. That the donor and the other inhabitants of the area shall be in possession of the land for the construction of the road namely... Holdang Ribba (the name of road) being constructed by the donee under the PWD Gram Sadak Yojana for public purposes as such he has decided to transfer the land by way of gift specified below voluntarily and without any consideration which has been accepted by the donee.
2. That the donor as referred above is owner in possession of land containing Khata/Khatauni.....Khasra No. 878/1.....Kha. 1 measuring 55.4 hectare extent ofshare in mauzaTehsil Moorang, Kinnaur, H.P.
3. That the donor further intend to transfer the land as mentioned above to the donee his/her share to the extent ofshare in whole Khata measuringhectare to the Department of HPPWD through Executive Engineer B&R Division Kalpa including all the structures, standing thereon, trees, garden etc. together with all rights easements and appurtenances whatsoever (hereinafter called the property hereby transferred).
4. That the Donor party is absolute owner in possession of the land mentioned hereinabove and has no objection, in case the above land is utilized for the benefit of the general public i.e. construction of road namely Holdang Ribba Kondo (specify the name of road) under (specify the name of the scheme) by the State Government on public exchequer.
