GIFT DEED
This GIFT DEED is made on this... 14th day of Oct 2015
BETWEEN Sh. Amit Lal S/o shri. Uday Phool
ident of village Ribbs Tehsil Murray Distt. Lehman HP
nachal Pradesh (hereinafter called DONOR) of the one part AND the State of H.P. through Executive
Engineer, B&R Division, HP PWD. Lehman Tehsil Murray District Lehman
nachal Pradesh (hereinafter called the DONEE) of the other part.

HEREBY it is declared as follows:-

- That the donor and the other inhabitants of the area shall be benefited by the construction of the road namely Holiday Ribbs Lehman (specify the name of road) being constructed by the donee under the Pradhan Mantri Gram Sadak Yojna for public purposes as such he has decided to transfer the land by way of gift specified below voluntarily and without any consideration which has been accepted by the donee.
- The donor party shall transfer the possession and ownership of land comprised in Khata/Khatuni No. 175 sub 125 Khasra No. 879 Measuring one - 1/2 hectare situated in Muhal Holiday Murray Distt. Lehman HP free from all encumbrances to the Donee party, including all the structures, standing thereon, trees, garden etc. together with all rights easements and appurtenance whatsoever (hereinafter called the property hereby transferred).
- That the Donor party is absolute owner in possession of the land mentioned hereinabove and has no objection, in case the above land is utilized for the benefit of the general public i.e. construction of road namely Holiday Ribbs Lehman (specify the name of road) under State Government on public exchequer. (Specify the name of the scheme) by the State Government on public exchequer.
- That the donor has agreed to deliver the possession of land at the time of the registration of the above gift deed.
- That the donor(s) has/have made this transfer of the land specified above voluntarily and without any consideration and the same has been accepted.
- That the donor party has further declare that no person including him/them or their successors shall have any right over the above land after the registration of the deed and the donee shall be the absolute owner of the land after wards for all intents and purposes and that neither the donor nor his legal representatives/heirs/successors shall claim any compensation for above mentioned land in future.

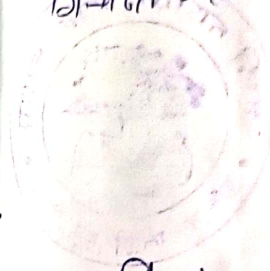
